Privacy Protection Notice

1. Member Data and Personal Information:

The personal information collected about our members for the purposes identified in this Privacy Protection Notice is maintained in various physical and electronic files, collectively referred to as "Member Data". The personal information included as Member Data may include your name, address and telephone number, business name, address and telephone number. Depending on services requested by our members, additional personal information may be included in your Member Data.

2. Providing Your Information to MV:

Members provide us with personal information through one of our representatives. **MV** collects this Member Data and uses it as needed to deliver our services to members, and when needed, discloses it only for the purposes identified in this Privacy Protection Notice.

3. Collecting, Holding, Using and Disclosing Information:
